**Membership Terms:**

- ❖ There is a limit of 1 cart for two players and 2 carts for foursome. Additional cart fees apply beyond these limits. Each seat on cart is charged a cart fee.
- ❖ **SPECIAL MEMBERSHIPS: Additional cart fee of \$12.32 plus tax(\$13) applies to each round** of up to 18 holes played.
- ❖ **Unlimited Membership:** Includes unlimited golf and cart Monday-Sunday.
- ❖ **Walking Membership:** Includes unlimited walking **golf Monday-Friday.** No walking on weekends or tournament days
- ❖ **Junior Membership:** This pass includes golf every day of the week. Junior pass holders may not make tee times (walk on basis only).
- ❖ Tax is not included in any membership fee.

**Additional Terms and Conditions:**

- ▶ **Ownership:** Passes are non-transferable and non-refundable.
- ▶ **No Memberships apply to Leagues, Tournaments or OTHER SPECIAL EVENTS**
- ▶ **Registering:** All Members must register with the Proshop staff PRIOR to using the facilities. Memberships do not entitle pass holders unauthorized or unlimited access without the knowledge and consent of the Proshop staff. Failure to comply may result in suspension or termination of all Golf privileges.
- ▶ **Golf Course Privileges:** Access to the golf course is subject to availability. Certain private events may dictate that the golf course, practice areas, restaurant and/or other areas of Valley Golf be closed. Member understands and agrees that nothing in this Agreement shall entitle pass holder to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facility and the restaurant and other privileges and benefits may be limited by Valley Golf Club as necessary.
- ▶ **Golf Cars:** Use of golf carts are restricted to Valley Golf customers. Golf cars MUST be signed out prior to each use. Only licensed drivers over the age of 18 may operate the cars. You must adhere to the rules and regulations, as set forth in the operation manual and/or all posted instructions.
- ▶ **Code of Conduct:** All Valley Golf Members, and their guests, agree to abide by the rules and regulations of Valley Golf. Any member may be expelled by the management for violation of any rule or regulation of Valley Golf or for conduct which in the opinion of the management is detrimental to the welfare, safety and character of Valley Golf.
- ▶ **Damage or Injury to Person or Property:** Member agrees to pay for any damages to the facilities or grounds, or for injuries to any person, caused by pass holder. Member also agrees to hold Valley Golf and its employees, agents, and owners, harmless and to defend

them against any and all claims, damages, and suits, for damages or injuries of any nature, whether to pass holder or to others, that may arise from or be related to members use of the golf course, its facilities or equipment.

► **Property and Equipment:** Valley Golf property includes equipment that is provided for our guests/members use. These items include towels and many other supplies that are provided. These items may not be taken out of their designated areas. Removal of these items from Valley Golf property will be deemed as theft and violators may be charged.

► **Fees and Charges:** Members understands and agrees that members are responsible for payment of all fees that may exist or arise and be charged by Valley Golf from time to time, unless such fees are included as pass holder benefits and privileges. Members understand and agrees to be responsible for all other charges incurred by member or by a guest of the member at Valley Golf, including but not limited to charges for food and service at the Valley Golf and Events/Roger’s Supper Club. Annual fee does not apply toward tournament play, leagues or special events.

► **Cancellation:** A breach of any of the terms and conditions of this contract will result in the cancellation of members rights and privileges without any reimbursement of any kind. Should member wish to cancel this agreement prior to its stated expiration for any reason whatsoever, there will be no refund, partial or otherwise, on the fees paid by member.

► **Miscellaneous:** In case any one or more of the provisions contained in this Agreement shall for any reason be held invalid, illegal, or unenforceable in any respect, such as invalidity, illegality, or unenforceability shall not affect any other provision, and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein. This Agreement embodies the entire agreement and understanding of the parties relating to the subject matter hereof, is non-assignable, may not be amended except in writing signed by both parties, and supersedes any prior representations, agreements, and understandings, oral or written, if any, relating to such subject matter.

► **Kids & Memberships** Kids in High School play free. College kids pay ½ price. Kids without drivers license cannot drive carts and they must pay for their seat on the cart if they ride with others. Junior memberships are walking only memberships. Questions please talk to Brad. Kids cannot make reservations – must stay out of paying members way, may be limited when course is busy, pay cart fees when riding with others
